OHSU policy No. 02-01-003

To promote the health and safety of all students and patients in their care, OHSU has established a drug testing program consisting of pre-matriculation testing, pre-clinical experience testing and "reasonable-suspicion" testing for any student suspected of being under the influence of lawful and/or unlawful drugs or alcohol during their course of study. All students accepted into educational programs with a clinical component shall be offered conditional admission pending the results of a pre-matriculation drug test. Failure of a pre-matriculation drug test may result in denial of admission into the academic program.

Please be aware that drug and alcohol test results will be considered confidential as required by federal and state law and may only be reviewed by OHSU officials and affiliated clinical facilities in accordance with the Family Educational Rights and Privacy Act (FERPA). Drug and alcohol testing reports and any submitted health information of students shall be maintained at OHSU in accordance with the OHSU record retention policies for student records.

The 10-panel drug test being administered tests for a variety of substances including, but not limited to, amphetamines, cocaine, marijuana, opiates, barbiturates, and methadone. While many states, including Oregon, have legalized the use of marijuana, OHSU continues to consider marijuana an illegal substance in adherence with current federal law.

Testing Window: May 6 – June 9, 2024

Testing locations:

- Local refer to A WorkSafe Collection Site Form for authorized collection sites
- Out-of-area Contact A WorkSAFE for an authorized collection site in your area.

Instructions for Student Testing:

- The drug test costs \$55.00 (OR) / \$60.00 (out-of-area) and must be paid <u>prior</u> to submitting for the test. Pre-pay for drug test by calling A WorkSAFE at 888-391-9363 to pay over the phone. **Payment** <u>will not be accepted</u> at the collection site.
- Print A WorkSAFE Collection Form and bring it with you to the collection site.
- Bring Government issued photo ID with you (OHSU student badge is not required)
- Refrain from drinking large amounts of liquids prior to testing. A 'Negative Dilute' test result will require a retest on another day.
- Do not list your medication.
