

- We have now defined "Received targeted temperature management" as part of the POST-ICECAP inclusion criteria. Please see the excerpt from the Manual of Procedures below:
- 3.3 The operational definition of Targeted Temperature Management in POST-ICECAP
  - O Any definitive temperature control device either initiated or ordered within 24 hours of cardiac arrest. All target temperatures including fever control and durations are acceptable (for example, an order during the first 24 hours to turn on a cooling device if temperature > 37.5°C would be "active fever control" even if turning on the device was never required.)
  - o Fever control using medications alone is not a sufficient eligibility criteria (for example, an order to administer acetaminophen for temperature >37.5 °C or even scheduled acetaminophen would not be considered "active" temperature management).

Pediatric Influence of Cooling Duration on Efficacy in Cardiac Arrest Patients

- At the Investigator Meeting there were a few requests for the visit window calculator (so you can figure out when visits are due).
  - o **It is in the PICECAP Toolbox under RESOURCES at the bottom!** Toolbox | SIREN. It is called "3 and 12 month Post CA Window Calculator" You'll download it, then put in the date of the cardiac arrest and it calculates the 3 and 12-month windows for you, as well as when you should start reaching out to families.

From the WINDSURFER team: We are planning on resubmitting the WINDSURFER proposal in July. For our last submission, we are grateful for the wide-reaching support and enthusiasm amongst the SIREN sites.
