3.D Veteran	Declaration	Residence = R Citizenship = <per app> Attribute = VETR	DD 214, Veteran ID card, or similar	Banner must list primary residence in Oregon; do not set Residence=R until this requirement is met
3.E VA benefit recipient	Declaration + VA Form	Residence = R Citizenship = <per app> Attribute = VETR	Declaration	Processed by Reg only; Banner must list primary residence in Oregon; do not set Residence=R until this requirement is met
