SIGNIFICANT PROFESSIONAL ACCOMPLISHMENTS

- From 2016 through 2022, led Fred Hutch team in multi-year negotiation of restructuring of cancer programs among Fred Hutch, UW Medicine, Seattle Children's and SCCA
